As you may know, earlier today Governor Cuomo set forth uniform standards to limit crowd capacity as the State combats the novel coronavirus or COVID-19.

Effective at 8pm tonight, Monday March 16<sup>th</sup> to comply with the Governor's directions, all GLOW YMCA locations will be closed until further notice. During this time, we will remain in close contact with the County Health Departments and County Leadership and we are committed to re-open as soon as we are permitted and deemed safe.
